

- 2) Alongwith the Admit Card only one of the documents in original viz.(i) Photo ID Card(Driving license, Pan Card, Voter Identity Card, Aadhaar Card, School/College ID Card) as a proof of identity is to be produced before the Invigilator.
- 3) Ball Pen would be provided to the candidates by the Invigilator at the Exam. Hall and accordingly the candidate should not bring any type of pen/pencil for the purpose of the examination.
- 4) Candidate should not carry/posses Mobile Phone/Pagers/Tablets or any other electronic gadget etc. inside the examination hall/campus and if any such device is detected, it will be confiscated and will be prosecuted as per rules in force for using unfair means.
