

Minutes of the District Level Committee(DLC) meeting of Axom Adarxo Gram Yojana(AAGY) held on 27.10.2020 at 3.00 P.M in the Conference Hall of the Deputy Commissioner, Karimganj.

The meeting was held under the chairmanship of Shri R.K.Laskar, ACS, D.D.C, Karimganj. At the outset, the District Development Commissioner welcome all the Hon'ble MLAs as well as the members from line Department present in the meeting.

Initiating the discussion, the District Development Commissioner reiterated that an amount of Rs.500.00 lakh has been received from Govt. under Axom Adarxo Gram Yojana(AAGY) for the year 2018-19 and an amount of Rs.50.00 lakh will be provided to the selected villages/GPs with a view to create Model villages in the district. The District Development Commissioner further informed the forum that 10(ten) villages/GPs have already been identified under Axom Adarxo Gram Yojana(AAGY) i.e. two villages in each Assembly Constituency which are as follows:



The DDC then informed that as per resolution of the last meeting held on 5th September'2020, all the BDOs were requested to submit Detailed Project Report(DPR) within 15th September'2020 for its approval in the District Level Committee(DLC) meeting. He further informed that the Block Development Officer, South Karimganj Development Block has submitted the DPR of Mahammadpur Pt-I & Bazarghat GP. Similarly Block Development Officer, Lowairpoa Development Block has submitted DPR of Kukital GP & Medly GP.

In a reply to a question, the BDO, Badarpur informed the forum survey completed and DPR of Masley Pt.I will be submitted before 30.10.2020. The DDC then requested all BDOs to update Annexure-III of guideline under AAGY before submission of the DPR.

As regards submission of DPR of Gamaria G.P and Binodini G.P under R.K.Nagar Development Block, Dargarbod G.P under Dullavcherra Development Block, Panighat G.P under North Karimganj Development Block, Bandorkuna G.P under Patherkandi Development Block, all the Block Development Officer were requested to submit the DPR of concerned village/GP by 30th October'2020 positively so that fund can be utilized within December'2020 and claim subsequent fund.


Further, DDC expressed his dissatisfaction over the performance of the Dullavcherra Development Block and no fruitful discussion in respect of village under Dullavcherra took place due to absence of BDO, Dullavcherra.

It was also informed that Namghar should not be included in the AAGY Scheme as there is separate provision for Namghar Scheme under Assam Darshan.

The August body on principle approved the DPR of Mahammadpur Pt-I & Bazarghat GP submitted by BDO, South Karimganj Dev. Block and DPR of Kukital GP & Medly GP submitted by BDO, Lowairpowa Dev. Block for its implementation under AAGY. The house also requested the DDC to take steps for speedy implementation of the scheme.

In fine, the District Development Commissioner requested all to work for all-round development of the identified villages so that the aim and objectives of the scheme may be fulfilled in due course.

The meeting ended with a vote of thanks from the Chair.


